### MISSION

Since 2013, our primary mission has been the promotion of the right to asylum through the dissemination of knowledge and expertise on asylum issues at EU and national level. We pursue this through three main areas of activity:

#### INFORMATION



Information about asylum seekers' countries of origin (COI) is crucial in the recognition of international protection. Professionals have free access to updated and verified COI thanks to our database, unique in Italy

#### RESEARCH



We examine legal and policy developments in the field of asylum in Italy and abroad. We collaborated with prestigious partners such as the European Council on Refugees and Exiles and the Emilia-Romagna Regional Authority.

#### TRAINING



We organise and participate in training, conferences, and seminars for asylum practitioners. Our training modules and other events, open to the general public, adapt to audience needs and current issues.

### VISION

#### WE BELIEVE IN KNOWLEDGE



AiE is committed to sharing accurate, up-to-date information about asylum legal and policy frameworks, both at the national and EU level. This will ultimately empower migrant populations and guarantee their access to fundamental rights.

## FOREWORD BY OUR PRESIDENT



2020 was certainly a tough year for everyone and Asilo in Europa has not been exempted from this. Travel restrictions and lockdown measures prevented us from meeting in-person and from organising in-person events. The pandemic impacted the lives of our volunteers at personal and professional levels. Yet, being dispersed across Italy and other European countries well before the pandemic, we found ourselves quite prepared to the new conditions of remote working, so we could build on this strength.

We were thus able to continue our important COI activity as well as our research, notably through the publication of our study on the work of the Tribunal of Bologna in field of international protection.

Although we were obliged to give up on some in-person events we had been planning, we took the lockdown as an opportunity to strengthen our digital presence and broaden our audience through the organisation of an online webinar series. This has been a success so far, contributing to an informed debate on relevant developments in the field of asylum in Europe and beyond.

The challenges ahead of us are exciting. Our Association has grown considerably in recent years, both in terms of members and followers.

Our goal is now to strengthen our management structure, improve our working procedures and consolidate our activities, while also acquiring a more pronounced international dimension.

We also intend to expand our digitalisation and communication activities.

The situation of asylum seekers and refugees in the world is ever more intolerable. We will continue to raise awareness, disseminate knowledge and build a welcoming culture, with the quality, distinctiveness and dedication that has characterised our work so far.

# We are proud of us

In less than 10 years, AiE has achieved a significant impact in both Italy and Europe.

Our freely accessible COI database, unique in Italy, has become a key reference for practitioners. It includes 210 COI fact sheets featuring 14 countries.

# COUNTRY OF ORIGIN INFORMATION (COI)

We published 19 new fact sheets in our database, adding new countries (Bangladesh, El Salvador, Venezuela, Tunisia) and keeping up-to-date those already covered.

We also produced 3 COI fact sheets upon request on the justice system in Ghana, the situation in Erbil (Iraqi Kurdistan), and mental health policies in Bangladesh. A lawyer who commissioned our COI fact sheets stated:

"The work of Asilo in Europa crucially enabled me to understand the problems of my clients and to defend them before Tribunals as well as the Ministry of Interior. In several appeals lodged by my law firm, and still pending, we could assist every single appellant thanks to the collaboration of Asilo in Europa. Their work was excellent. It allowed me to consider thoroughly every individual case"

# We are proud of us

On its social media platforms, AiE counts on a fast-growing network of almost 13,000 followers. In 2020, our website was visited 30,798 times, mostly by young users (below 35 years of age).

On the Emilia Romagna Regional Authority's website, the section on asylum seekers and refugees to which AiE largely contributed has been visited 1,711 times. The content produced by AiE received 72,9% of the total number of views (1,249)

## ACHIEVEMENTS

#### DIGITAL ENGAGEMENT

In 2020 alone, we estimate we reached at least 4,360 people through our online training and public events

# We are proud of us

AiE has 49 members and is run by an Executive Board composed by 7 members, including the President. In 2020, all its members were volunteers.

While most members live in different areas of Italy, AiE is also present in Spain, France, Belgium, Malta, and the UK, amongst other countries.

The vast majority of AiE members are women (81.6%), also occupying 6/7 of the Board seats.

68% of us are young people, aged less than 35 years old.

### ACHIEVEMENTS

#### ADVOCACY

On September 23rd, the European Commission published the "New Pact on Migration and Asylum", thereby presenting five proposals for regulations and three recommendations. AiE published a technical analysis of these documents, which is freely accessible online.



#### **OPEN KNOWLEDGE**

More than 350 documents are available and freely accessible on AiE's website: fact sheets, comparative analyses, legal commentaries as well as academic theses on international protection.

#### RESEARCH

In 2020, AiE published a study on the decisions made by the Court of Bologna on international protection appeals lodged between August 2017 and December 2018.

The study stems from a collaboration between AiE, the Emilia-Romagna Regional Authority, the Court of Bologna.

The research is based on quantitative and qualitative data, and it also includes a focus on applicants from Bangladesh and Nigeria. Research findings have been presented in a number of public events.

The publication of the annual report is the first step in this regard, which will be followed by other measures, such the permanent improvement of our website and the definition of an accountability policy towards our beneficiaries.

The adhesion to shared ethical guidelines fits with AiE's scope of action: the promotion of in-depth knowledge and information sharing to the benefit of asylum seekers and beneficiaries of international protection.
